First-aid measures general	: Check the vital functions. Unconscious: maintain adequate airway and respiration. Respiratory arrest: artificial respiration or oxygen. First-aid measures after eye contact	: Rinse immediately with plenty of water. Take victim to an ophthalmologist if irritation persists.
First-aid measures after ingestion	: Rinse mouth thoroughly with water. Do not induce vomiting. Ingestion of large quantities: immediately to hospital.
